



# Contract

## Hotel Pies i Przyjaciele Cat / Dog Boarding Contract

**On day** ..... between the Hotel for Pets "Pies i Przyjaciele" with its headquarters in Krakow, 13 Kapielowa St. represented by Mrs. Dominika Oryńska - Woźniak, hereinafter referred to Hotel", and ..... "Entrusting"

a contract was concluded that reads as follows:

### § 1.

1. The entrusting person puts under the care of the Hotel a dog / cat of the breed :.....  
..... bearing the name ....., for the period from .....  
to .....
2. The Entrusting declares that the dog / cat referred to in-paragraph 1 is:
  - a) his / her ownership,
  - b) is owned by .....
3. The Entrusting declares that in the case referred to in para. 2 point 2, has the full right to put a dog / cat under the care of the Hotel, given to him by the owner of the animal.

### § 2.

1. The Entrusting declares that the dog / cat entrusted to the Hotel's care:
  - a) has current vaccinations,
  - b) has been protected against ticks.
2. The Entrusting declares that the dog / cat given to the Hotel's care is healthy and does not require specialist care.
3. For the duration of stay in the Hotel, the Entrusting leaves:
  - a) dog / cat health book,
  - b) collar, leash.

### § 3.

1. The entrusting person transfers the dog / cat to the Hotel Pies i Przyjaciele.  
The cost of a dog stay at the Hotel in the agreed period has been set and amounts to

The payment was made on the day of accepting the dog / cat

### § 4.

1. In connection with the conclusion of this contract, the Hotel undertakes to:
  - a) care of the dog / cat,
  - b) do its utmost to shorten acclimatization of the animal in the Hotel by individual treatment, the appropriate dose of play and caresses, and also providing contacts with other animals (if possible),
  - c) provide periodic information about the animal - according to mutual agreement,

- d) feed the dog / cat in accordance with the offer or according to the principles established jointly with the entrusting,
  - e) take care of the physical and psychological state of the entrusted animal, and if necessary - taking care of it immediately informing the Entrusting about this fact
2. In connection with the conclusion of this contract, the Entrusting undertakes to:
- a) inform the Hotel about the current state of health of the transferred dog / cat,
  - b) inform the Hotel about the character of the transferred dog / cat, which will allow to limit / avoid possible conflicts with people and other animals,
  - c) hand over various kinds of tips that the Entrepreneur deems important,
  - d) payment settlement,
  - e) pick up a dog / cat from the Hotel within the time limit specified in the contract,
  - f) the payment of all costs related to the possible treatment of the animal which has arisen during your stay at the Hotel. Settlement for veterinary services on the basis of bills without charging commission.

#### **§ 5.**

- 1. The date of stay at the Hotel set in this agreement may be changed - with the consent of the Hotel.
- 2. In the case of shortening the stay, the Entrusting is obliged to pay the full amount.
- 3. In the case of extension - with the consent of the Hotel - the date of stay, the 3. Entrusting is obliged to pay the costs established with the Hotel.
- 4. In the case when the Entrusting:
  - a) will not transfer full payments referred to paragraph 3,
  - b) will not contact the Hotel regarding the extension of stay of the dog / cat and will not answer Hotel telephones,
  - c) it turns out that the telephone number given in the Application Form is out of date and the Entrusted has not updated it,
  - d) the entrusting person or authorized by him in writing - without notifying the Hotel and complying with the requirements, referred to paragraph 2 and 3, will not pick up the dog / cat within 5 days after the expiration of the pickup date, as specified in this contract.

The parties agree that § 6 of this contract applies.

#### **§ 6.**

- 1. In the situations referred to in 5 para. 4 of this contract, the dog / cat referred to above will be forwarded to shelter or foundation, and the owner / entrusting will be charged with all related costs and will make no claims against Hotel Pies i Przyjaciele.

- 1. This contract has been made in two copies, one for each party.
